



GDB completes construction of Menara Etiqa

- ***Receives CPC dated 13 July 2018; completes Menara Etiqa ahead of contractual completion date***

Selangor, Malaysia, 30 July 2018 - Construction services firm **GDB Holdings Berhad** (GDB, GDB 控股有限公司, Bloomberg: GDB:MK, Reuters: GDBH.KL) delivered ahead of schedule the construction of Menara Etiqa at Jalan Bangsar, Kuala Lumpur, and today received the Certificate of Practical Completion (CPC) dated 13 July 2018.

Reputed to be an efficient construction company, GDB completed the iconic tower, Menara Etiqa, in advance of its contractual completion date of 31 July 2018.

GDB was appointed by Etiqa Insurance Berhad as the main contractor for the construction of Menara Etiqa over a 24-month period. Construction works on the project commenced on 1 August 2016.

At contract value of RM186.6 million, the 38-storey Menara Etiqa office tower consists of 27 floors of office space, 3 floors of recreation space, 1 floor of mechanical space, a 7-storey podium carpark, and a three-and-a-half-storey underground carpark.

GDB was awarded a Five-Star Safety and Health Assessment System in Construction (SHASSIC) certification for Menara Etiqa by the Construction Industry Development Board in 2017, having achieved a high score of 96%.

GDB was also awarded the certificate of achievement by SIRIM in 2017 for implementing the Green 5-S Program. This represents the Group’s commitment to quality, health and safety, environment conservation, productivity, and professional image.

Apart from Menara Etiqa, GDB had also delivered several projects ahead of their contractual completion dates, namely One Central Park in Desa ParkCity and KL Eco City in Kuala Lumpur city.
